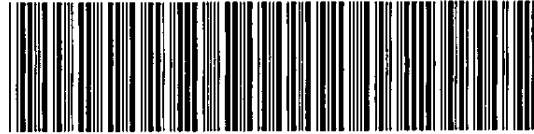

We, the President and the Secretary of KINSEY, TROXEL, JOHNSON, WALBORSKY & BRADLEY, P.A., now known as KINSEY, TROXEL, WALBORSKY & BRADLEY, P.A., a professional service corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

(1) The name of the Corporation is KINSEY, TROXEL, JOHNSON, WALBORSKY & BRADLEY, P.A.

(2) The following amendment has been adopted in accordance with the requirements set forth in Chapters 607 and 621 of the Florida Statutes:

Article I of the Articles of Incorporation of the Corporation, as amended, is deleted in its entirety, and replaced with the following new Article I:

ARTICLE I

The name of the corporation shall be KINSEY, TROXEL, WALBORSKY & BRADLEY, P.A.

(3) The date of the adoption of this amendment is the 22 day of November, 2011. This amendment shall be effective as of the date of filing with the Florida Department of State.

(4) The Corporation has only one class of stock, such that there is only one voting group entitled to vote on this amendment. The number of votes cast for this amendment by such voting group was sufficient for approval by said voting group.
