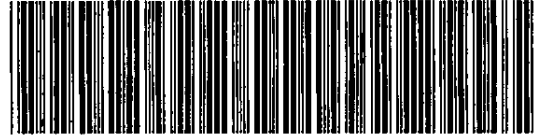

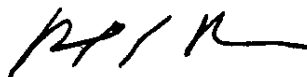

The dissolution of the corporation was approved by the shareholders, and the number cast for dissolution by the shareholders was sufficient for approval. Voting by voting groups was not required.

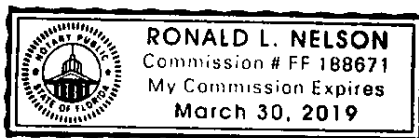
