Pursuant to notice of all shareholders a meeting was called to by the President, Howard C. Coker. Mr. Coker declared the meeting was ready to proceed with business.


At that time the shareholders voted to change the name of the corporation to Coker, Schickel, Sorenson, Posgay, Camerlengo & Iracki, P.A.
