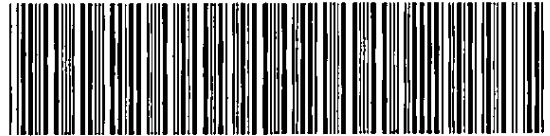

Name: The name of the corporation is **MCF INVESTMENT HOLDINGS, INC.**


The present principal place of business of this corporation is 7744 US Open Loop, Lakewood Ranch, FL 34202."

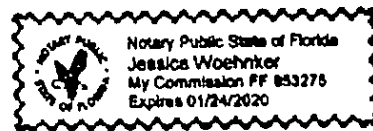
