Pursuant to Chapter 607, Florida Statutes, the undersigned, being the President of Johnson,
Green, Miller & Gibson, P.A., a Florida corporation (the "Corporation"), does hereby state:

1. The Corporation adopts the following amendments to its previously filed Articles of
Incorporation, as amended:

A. The Corporation amends Article I of its Articles of Incorporation by deleting such
Article I in its entirety and substituting in its place a new Article I that reads as follows:


ARTICLE I - NAME

1976, and as amended from time to time, shall remain in full force and effect.


3. The Board of Directors of the Corporation propose the above amendments to the Articles

approval of these amendments, approved the above stated amendments on March 1, 2002.


