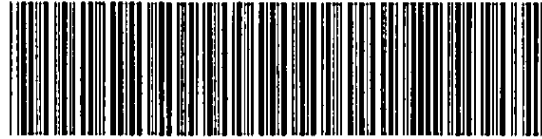



The foregoing Amendment was adopted by the Stockholders and Officer pursuant to Sections 607.1002 and 607.1003, Florida Statutes.


