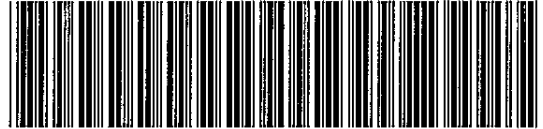

*unanimously*

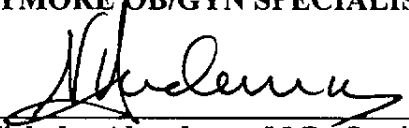
