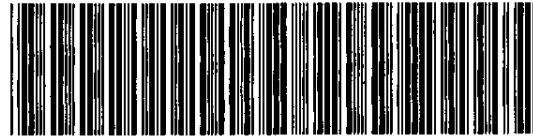


1. The current name of the corporation is SANG WHANG ENTERPRISES, INC.
