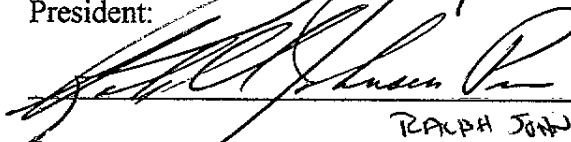
**ARTICLES OF DISSOLUTION OF CORPORATION**
