- (1) FIRST: The name of the corporation is CREATIVE PLASTICS, INC.
- (2) SECOND: The date dissolution was authorized: December 31, 1999.
- (3) THIRD: Adoption of Resolution: Dissolution was unanimously approved by the shareholders. The number of votes cast for dissolution was sufficient for approval.
- (7) FOURTH: Relinquishing Name Of Corporation: The shareholders adopted a resolution approving relinquishing the name of the corporation for assumption or use by another corporation immediately.
