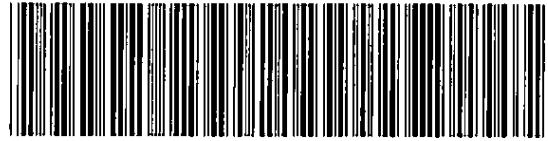



AMENDED AND RESTATED ARTICLES OF INCORPORATION

Pursuant to provisions of Section 607.1006, Florida Statutes, this Florida For Profit Corporation adopts the following amendments of the Florida Business Corporation Act, (the "Code"), the Articles of Incorporation of THE CYLINDER SHOP, INC., a Florida corporation (the "Corporation") are hereby amended according to these Articles of Amendment:

**NAME**

The name of the Corporation is **THE CYLINDER SHOP, INC.**

The Articles of Incorporation of the Corporation are hereby amended by deleting the Section titled "AUTHORIZED SHARES" and substituting in lieu thereof the following Section:

**"AUTHORIZED SHARES**

The maximum number of shares that the Corporation is authorized to have outstanding at any time is One Thousand Five Hundred (1,500) shares of common stock having a par value \$0.01 par value per share."

The foregoing amendments were duly adopted and approved on January 1, 2020, by the Board of Directors and all of the Stockholders of the Corporation in accordance with Section 607.1006, Florida Statutes, as amended.
