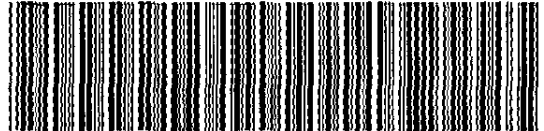

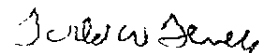

**SECOND AMENDMENT TO ARTICLES OF INCORPORATION
OF
CREDIT DATA SERVICES, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida Profit Corporation adopts the following amendment to its Articles of Incorporation, which were filed with the Florida Department of State on March 7, 1977, as subsequently amended and restated on March 27, 1997, and assigned Document No. 528731.

The following amendment to the Articles of Incorporation was adopted by the Board of Directors and Shareholders of the Corporation holding the requisite number of the outstanding shares of Voting Common Stock of the Corporation and being the majority necessary pursuant to the Bylaws of the Corporation to adopt such Amendment in the manner prescribed by the Florida General Corporation Act.

Article I of the Amended and Restated Articles of Incorporation of CREDIT DATA SERVICES, INC., shall be amended to read as follows:

NAME**

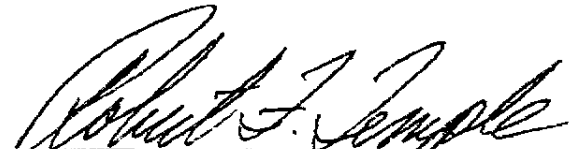
The name of the Corporation is: **CHAFFBRACK, INC.**
