ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, LE JEUNE ORTHOPEDICS ASSOCIATES, DRs. SANCHEZ-MEDINA, CALDWELL & BEAPERTHUY-ROJAS, P.A., a Florida professional association (the "Corporation"), adopts the following articles of amendment to its articles of incorporation which were filed with the Florida Department of State on April 1, 1977, Charter Number 529465.

FIRST: Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

Article I
