ARTICLES OF INCORPORATION

OF

VANGUARD REALTY, INC. A FLORIDA CORPORATION

Pursuant to the provisions of Chapter **607**, Florida Statutes, as amended, the undersigned Florida corporation, Vanguard Realty, Inc, adopts the following Amended and Restated Articles of Incorporation. This Corporation's Articles of Incorporation were filed on March 22, 1977; Document Number **529785**.

ARTICLE I - NAME

The name of this corporation is as follows:

ARTICLE II - PRINCIPAL OFFICE

These Amended and Restated Articles of Incorporation may be amended by a simple majority vote (greater than 50.0%) of the voting stock of the Corporation that is present, at any regular meeting of the Shareholders or at any special meeting of the Shareholders called for that purpose, at which a quorum is present. These Amended and Restated Articles of Incorporation shall not be amended or repealed without a meeting.
