I was advised on October 24, 1997 by a local Punta Gorda person that Punta Gorda Isles Sales, Inc. had been administratively dissolved by the State of Florida. Knowing that I still needed this corporation to be authorized to do business in Florida, the person mentioned this information to me when I called them about another matter.

I called the Florida Department of State on Monday, October 27 and received voice mail response regarding this issue. Being uncomfortable with that, I followed up again today and talked to Shawn in the Reinstatement Division. He suggested that I write this letter giving the record of my conversations with the Florida Department of Revenue regarding this corporation and include payment of the 1996 and 1997 annual report fee.

I last filed an annual report for 1995 for this corporation (copy enclosed). When we wanted to sell property in December, 1995 we found that the registered agent and officer was still shown as Paula McQueen. I called Florida 1/16/96 regarding this and was told that indeed the state had received the annual report and that they just failed to update the file. Our procedure for making the change was correct. (I did note at this time that we failed to change the mailing address in block 2a. on the form.) I was told by Lelanie that she would look up the original report and make the changes on the file.

During a follow up call 8/7/96 looking for the 1996 annual report, I was told that the changes were appearing on the file. Since I had not received a 1996 annual report to file, a blank form would be sent out. The person said the original form was sent to the 1625 Marion Avenue address. I requested that it be sent to our new address because to remail to the same place was probably not going get to me either. A new address was given at that time inasmuch as we had moved from our St. Louis address at 515 Olive Street June 30, 1996 to our current location at 212 South Central. No form arrived.
