## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF DOOLEY AND MACK CONSTRUCTORS, INC.

98 NOV 18 AM 11: 26

The following provisions of the Articles of Incorporation of the Dooley and Mack Constructors, Inc., a Florida corporation, filed of April 26, 1977, as previously amended by Articles of Amendment filed with the Secretary of State on August 27, 1985, are amended in the following particulars:

## 1. Article III is amended to read as follows:

The Corporation is authorized to issue 100,000 shares of \$.01 par value common stock, which may be fractional shares. All stock, when issued, shall be fully paid and non-assessable.

## 2. Paragraph (L) of Article XII is amended to read as follows:

No shareholder of the Corporation shall be entitled to have any pre-emptive or preferential rights to any unissued or treasury shares of the Corporation or securities of the Corporation convertible into or carrying a right to subscribe to or acquire such shares; and any shares of stock or convertible obligations which the Corporation may determine to offer for subscription to the holders of stock may, as the Board of Directors shall determine, be offered in such proportions to the shareholders as the Board of Directors, in its discretion, may determine.

The foregoing amendments were adopted by the shareholders of the Corporation on <u>November 11</u>, 1998.
