(the Corporation) pursuant to Florida Statute 607.106 at a joint meeting of stockholders, officers and directors held May 18, 2000, hereby unanimously amend and restate Article III of the Articles of Incorporation of this Corporation to read as follows:


"ARTICLE III-CAPITAL STOCK


The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred Fifty (150) shares of common stock having a nominal or par value of One Dollar (\$1.00) per share.

None of the shares of this corporation may be issued to anyone other than an individual duly licensed to practice as an architect in the State of Florida."

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.

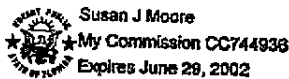
