2. The name of the corporation shall be changed to Price & Price Law Group, Chartered, effective upon the earliest date permitted by law.

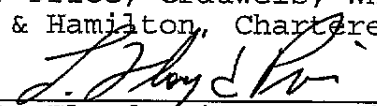
3. The date of the adoption of this Amendment by the Board of Directors and Shareholders is the 10th day of November, 1998.

4. The said amendment was approved by unanimous consent of all shareholders entitled to vote.

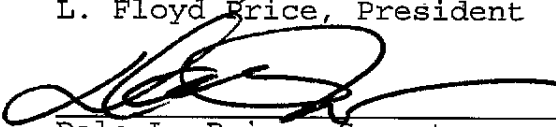
