1. The name of the Corporation is Krupnick Campbell Malone Buser Slama Hancock Liberman & McKee, P.A.

2. Article I, "CORPORATE NAME," of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE ICORPORATE NAME

The name of the corporation shall be Krupnick Campbell Malone Buser Slama Hancock Liberman, P.A."

3. The foregoing amendment was adopted by the Directors and Shareholders of the Corporation eligible to vote by a Written Consent signed by them on Sept 3, 2013, manifesting their intention that this amendment to the Articles of Incorporation be adopted, pursuant to Section 607.1003, Florida Statutes.
