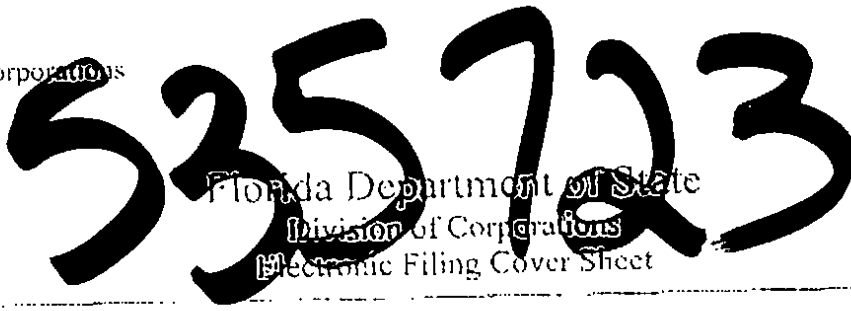

ARTICLES OF AMENDMENT
TO THE
RESTATED ARTICLES OF INCORPORATION
OF
KRUPNICK CAMPBELL MALONE BUSER SLAMA HANCOCK LIBERMAN, P.A.

Pursuant to the provisions of Section 607.1006, Florida Statutes, Krupnick Campbell Malone Buser Slama Hancock Liberman, P.A., a Florida Profit Corporation, adopts the following amendment to its Restated Articles of Incorporation:

1. Article I, "NAME," of the Restated Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE I

NAME


The name of the corporation is Krupnick Campbell Malone Buser Slama Hancock, P.A."

2. The foregoing amendment was adopted by all of the shareholders and directors eligible to vote by a Written Consent signed by them on January 29, 2019, manifesting their intention that this amendment to the Restated Articles of Incorporation be adopted, pursuant to Section 607.1003, Florida Statutes.

3. The effective date of these Articles of Amendment is February 1, 2019.

4. The amendment was adopted by all of the shareholders and directors. The number of votes cast for the amendment by the shareholders and directors was sufficient for approval.
