AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SALLY INDUSTRIES, INC.

ARTICLE I

The name of this Corporation shall be Sally Industries, Inc.

ARTICLE II

The corporation shall exist perpetually.

ARTICLE III

This corporation is organized for the purposes of transacting any or all lawful business.

ARTICLE IV

This Corporation is authorized to issue Five Million (5,000,000) shares of common stock, all of which shall be of the par value of Ten Cents (\$.10) per share. The Board of Directors of this Corporation may elect at any time to redeem the issued and outstanding common stock of any shareholder who owns less than one thousand (1,000) shares of stock in the aggregate. The shares shall be redeemed pursuant to procedures set forth in the Bylaws of this Corporation.

ARTICLE V

ARTICLES OF AMENDMENT AND RESTATEMENT OF THE ARTICLES OF INCORPORATION OF SALLY INDUSTRIES, INC.

- A. The name of this Corporation is Sally Industries, Inc.
- **B.** Amendments to the Articles of Incorporation were adopted on April 16, 2001, by the holders of a majority of the issued and outstanding common stock of this Corporation to amend Article IV of the Articles of Incorporation to provide that the shares of common stock of the Corporation owned by any shareholder owning less than one thousand shares are redeemable at any time by the action of the Board of Directors and to delete Article VI. Article IV, as amended, shall read as follows:

"ARTICLE IV

This Corporation is authorized to issue Five Million (5,000,000) shares of common stock, all of which shall be of the par value of Ten Cents (\$.10) per share. The Board of Directors of this Corporation may elect at any time to redeem the issued and outstanding common stock of any shareholder who owns less than one thousand (1,000) shares of stock in the aggregate. The shares shall be redeemed pursuant to procedures set forth in the Bylaws of this Corporation."

There are no other amendments to the Articles of Incorporation, except as stated above.
