## ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF <u>AROUND THE WORLD TRAVEL, INC.</u>

Pursuant to the requirements of Sections 607.1002 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Amended and Restated Articles of Incorporation of Around the World Travel, Inc. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on June 29, 1977:

1. All the members of the Board of Directors of the Corporation have unanimously voted to amend Article VI of the Amended and Restated Articles of Incorporation of the Corporation to provide that if the Corporation acquires its own shares, such shares belong to the Corporation and constitute treasury shares until disposed of or canceled by the Corporation. Therefore, the Corporation hereby amends Article VI, <u>Capital Stock</u>, of the Amended and Restated Articles of Incorporation to add a provision, the content of which is hereafter set forth:

3. If the Corporation acquires shares of its own Common Stock or Preferred Stock, such shares shall belong to the Corporation and shall constitute treasury shares (as defined by the Florida Business Corporation Act) until disposed of or canceled by the Corporation.

2. All other provisions of the Corporation's Amended and Restated Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.

3. The foregoing amendment to the Amended and Restated Articles of Incorporation was unanimously adopted by the Board of Directors of the Corporation without shareholder action on the  $29^{\circ}$  day of <u>January</u> 2001, to be effective as of December 23, 1999. Shareholder action was not required pursuant to Section 607.1002(8), Florida Statutes.
