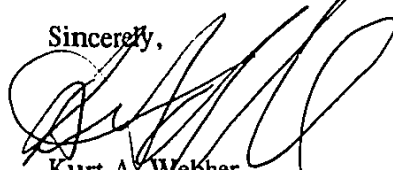

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
JANSEN PROPERTIES OF FLORIDA, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned sole director and sole shareholder of Jansen Properties of Florida, Inc. ("Corporation"), a corporation organized and existing under the laws of the State of Florida, executes these Articles of Amendment to the Articles of Incorporation of Jansen Properties of Florida, Inc. ("Articles of Amendment") and does hereby certify:

1. The Articles of Incorporation were filed with the Florida Secretary of State on August 8, 1977 ("Articles").

2. The Articles of Amendment change the name of the Corporation from Jansen Properties of Florida, Inc. to PQ Investments, Inc. and document the change in number and membership of the Board of Directors.

3. Article "First" of the Articles is deleted and replaced with the following:

"First: The name of the corporation (hereinafter called the corporation)
is

PQ Investments, Inc."

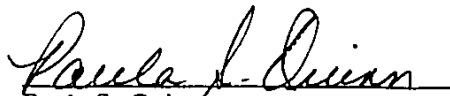
4. Article "Seventh" of the Articles is deleted and replaced with the following:
