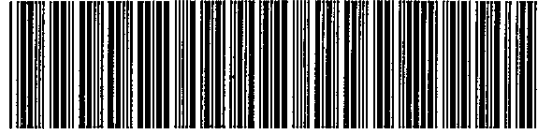

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation, being a profit corporation organized under the laws of the State of Florida, submits the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is CD of Panama City, Inc. (the "Corporation"), and the document number for the Corporation, as assigned by the Florida Department of State, is 542736.

2. The Articles of Incorporation of the Corporation are hereby amended as follows:

A. Paragraph 6 of the Articles of Incorporation of the Corporation is hereby amended by deleting the same in its entirety and inserting the following in its place and stead:

6. The street address of the principal office of the Corporation is 225 West 23rd Street, Panama City, Florida 32405, and the mailing address of the Corporation is 918 8th Avenue, South, Nashville, Tennessee 37203.

B. Paragraph 7 of the Articles of Incorporation of the Corporation is hereby amended by deleting the same in its entirety and inserting the following in its place and stead:

C. Paragraph 8 of the Articles of Incorporation of the Corporation is hereby amended by deleting the same in its entirety and inserting the following in its place and stead:

D. Paragraph 10 of the Articles of Incorporation of the Corporation is hereby amended by deleting the same in its entirety and inserting the following in its place and stead:

3. The foregoing amendments to the Articles of Incorporation of the Corporation do not provide for an exchange, reclassification or cancellation of issued shares of the Corporation.

4. The date upon which the foregoing amendments to the Articles of Incorporation of

the Corporation were adopted is July 19, 2004.

5. The foregoing amendments to the Articles of Incorporation of the Corporation were approved by the shareholders of the Corporation. The number of votes cast for the amendments by the shareholders was sufficient for approval.
