The name of the corporation is: SUNSHINE CAP COMPANY

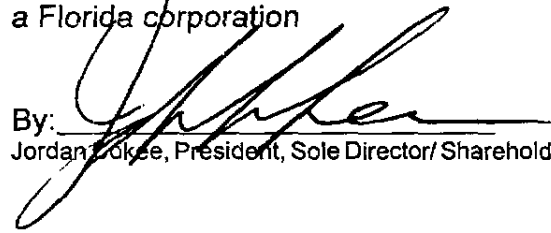

**ARTICLE III**

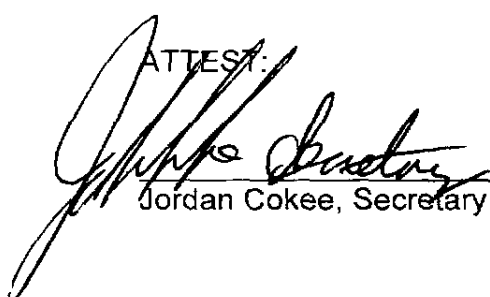

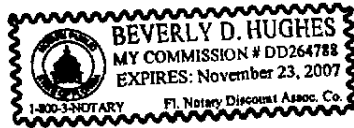
