ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

RISSMAN, WEISBERG, BARRETT, HURT, DONAHUE & MCLAIN, P

RISSMAN, WEISBERG, BARRETT, HURT, DONAHUE & MCLAIN, P.A., corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby certifies as follows:

- 1. The name of the Corporation is Rissman, Weisberg, Barrett, Hurt, Donahue & McLain, P.A. The date of filing of its original Articles of Incorporation with the Secretary of State was September 8, 1977.
- 2. Pursuant to and in accordance with Sections 607.1003 and 607.1006, <u>Florida Statutes</u>, these Articles of Amendment to Articles of Incorporation amend certain provisions of the Articles of Incorporation of this Corporation. These Articles of Amendment to Articles of Incorporation were authorized, approved, and ratified by the Board of Directors and the Shareholders of the Corporation in accordance with Sections 607.0704 and 607.0821, respectively, of the Florida Business Corporation Act.
- 3. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following shall be inserted in lieu thereof:

"ARTICLE I - NAME

The name of this corporation is RISSMAN, BARRETT, HURT, DONAHUE & MCLAIN, P.A."

4. The foregoing amendment to the Articles of Incorporation was unanimously adopted by all of the members of the Board of Directors and all of the Shareholders of the Corporation on the >\(\frac{1}{2}\) day of \(\frac{1}{2}\) ARMALY, 2006.
