Pursuant to Section 607.1006 of the Florida Statutes, SEGREST & MILLER CORP. Corporation organized and existing under and by virtue of the laws of the State of Florida (the "Corporation"), does hereby certify:

FIRST: Name. The name of the Corporation is Segrest & Miller Corp.
