ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WESCHE JEWELERS, INC.

Pursuant to Section 607.103, Florida Statutes, WESCHE JEWELERS, INC., a Florida corporation, hereinafter called the "corporation" hereby amends its Articles of Incorporation as follows:

1. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I. NAME

The name of this corporation is: WOODS & ASSOCIATES, INC.

- 2. The shareholders at the direction of the corporation acting pursuant to Section 607.0704, 607.0821 and 607.1003, Florida Statutes, have executed a written consent adopting the foregoing amendment.
