ARTICLES OF INCORPORATION OF

I the undersigned, being the President of HUNT & SMITH LAW FIRM, P.A., a Florida corporation, hereby certify that the following Amendment to the Articles of Incorporation was duly adopted unanimously by all of the Directors and all of the Shareholders at a meeting duly held by them on the 23rd day of January, 2018:

AMENDMENT

- 1. The name of the corporation is HUNT & SMITH LAW FIRM, P.A. (the "Corporation").
- 2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

"Article I

The name of the Corporation shall be D. ANDREW HUNT, P.A."

- 3. This Amendment was recommended by the Board of Directors to the Corporation's Shareholders on the 23rd day of January, 2018.
- 4.
