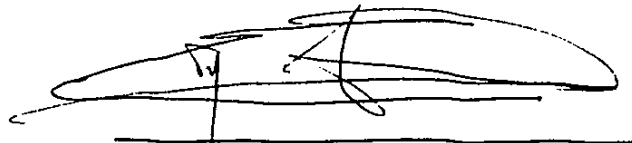
ARTICLE I. NAME
