Pursuant to the provisions of Sections 607.1101 and 607.1105, Florida Statutes, the undersigned corporations adopt the following Articles of Merger for the purpose of merging Gastroenterology Associates of Orange Park, P.A., a Florida professional association, into Borland-Groover Clinic, P.A., a Florida professional association.

#### PLAN OF MERGER

This Plan of Merger, dated this <u>29</u> day of April 1997, is entered into pursuant to Section 607.1101, Florida Statutes, for the merger of Gastroenterology Associates of Orange Park, P.A., a Florida professional association, into Borland-Groover Clinic, P.A., a Florida professional association. Borland-Groover Clinic, P.A. is to be the surviving corporation.

#### RECITALS:

A. Gastroenterology Associates of Orange Park, P.A. has issued and outstanding 1200 shares of common stock with the par value of \$1.00 per share. All of the stock of Gastroenterology Associates of Orange Park, P.A. is owned by the following licensed physicians:

B. Borland-Groover Clinic, P.A. is a Florida professional association which has issued and outstanding 1050 shares of common stock with the par value of \$1.00 per share. All of the stock of Borland-Groover Clinic, P.A. is owned by the following licensed physicians:

C. Economies of operation and savings in administrative expenses can be achieved by merging Gastroenterology Associates of Orange Park, P.A. into Borland-Groover Clinic, P.A.

### **MERGER PROVISIONS:**

- 1. In accordance with the provisions of this Plan of Merger and the Florida Business Corporation Act, on the Effective Date (as defined below), Gastroenterology Associates of Orange Park, P.A. shall be merged into Borland-Groover Clinic, P.A. and the separate corporate existence of Gastroenterology Associates of Orange Park, P.A. shall cease and Borland-Groover Clinic, P.A. (the "Surviving Corporation") shall continue its corporate existence as a Florida corporation pursuant to the laws of Florida (Gastroenterology Associates of Orange Park, P.A. and Borland-Groover Clinic, P.A. are herein collectively referred to as the "Constituent Corporations").
  - 2. The merger shall become effective on May 1, 1997 (the "Effective Date").
- 3. The Surviving Corporation shall possess and retain every interest in all assets and property of every description of each of the Constituent Corporations. The rights, privileges and immunities, powers, franchises and authority of a public as well as of a private nature of each of the Constituent Corporations shall be vested in the

Surviving Corporation without further act or deed subject, however, to the limitations on the powers of Borland-Groover Clinic, P.A. imposed by its Articles of Incorporation and Florida law. The title to and any interest in all real and personal property vested in any of the Constituent Corporations shall not revert or in any way be impaired by reason of the merger.

- 4. All obligations belonging to or due to each of the Constituent Corporations shall be vested in the Surviving Corporation without further act or deed, and the Surviving Corporation shall be liable for all obligations of each of the Constituent Corporations existing as of the Effective Time.
- 5. On the Effective Date, by virtue of the merger and without any action on the part of the parties or otherwise, each six shares of stock of Gastroenterology Associates of Orange Park, P.A. shall be converted into one (1) share of stock in Borland-Groover Clinic, P.A. (i.e. a ratio of 1 share for 0.166666 shares). Each issued and outstanding share of stock of Gastroenterology Associates of Orange Park, P.A. shall be cancelled.
- 6. The Shareholders of Gastroenterology Associates of Orange Park, P.A. or Borland-Groover Clinic, P.A. who dissent from the merger described herein may be entitled, pursuant to Section 607.1320, Florida Statutes, if they comply with the provisions of the Florida Business Corporation Act, Chapter 607, Florida Statutes, regarding the rights of dissenting shareholders, to be paid the fair value of their shares.
- 7. This Plan of Merger may be abandoned without the approval of the shareholders of either Gastroenterology Associates of Orange Park, P.A. or the

shareholders of Borland-Groover Clinic, P.A. at any time prior to filing the Articles of Merger. The procedure for abandoning the Plan of Merger shall be the adoption of a resolution to abandon the merger by the Board of Directors by either Gastroenterology Associates of Orange Park, P.A. or by the Board of Directors of Borland-Groover Clinic, P.A. followed by written notice to the President of the other corporate party to the merger.
