**ARTICLES OF AMENDMENT

Pursuant to Sections 607.1001 and 607.1006 of the Florida Business Corporation Act, WAYNE D. BRADLEY, D.D.S., P.A., a Florida professional corporation (corporate document number 553467) (the "Corporation"), hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation as follows:

ARTICLE I

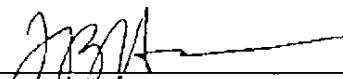
The name of the Corporation shall be changed, and its new name shall be:
