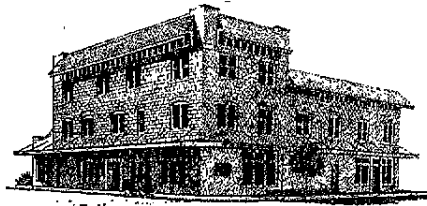

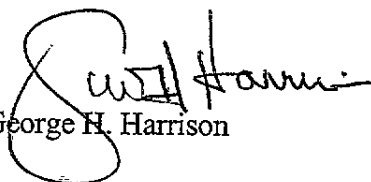

AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

SERVICE INSURANCE COMPANY

The undersigned President and Secretary of SERVICE INSURANCE COMPANY, a corporation organized under the laws of the State of Florida, hereby certify:

1. That the name of the corporation is SERVICE INSURANCE COMPANY
2. The Articles of Incorporation of said corporation are hereby amended by deleting all words and figures contained in Article III - Capital Stock and inserting the following in place and stead thereof:

"ARTICLE III - CAPITAL STOCK

The total number of shares of capital stock which may be issued by this corporation shall be Five Hundred Thousand (500,000) shares of common stock with a par value of \$4.00 each, and all of which shall be fully paid and non-assessable."

3. In all other respects the Articles of Incorporation are ratified, reaffirmed and remain unchanged.
4. The above Amendment to the Articles of Incorporation of SERVICE INSURANCE COMPANY was adopted by the Board of Directors and recommended to the Shareholders on the 12th day of March, 1999, for their approval and thereafter, upon notice as required to each Shareholder entitled to vote, the same was adopted by a majority of the Shareholders at a Shareholders' Meeting held on the 12th day of April, 1999.
