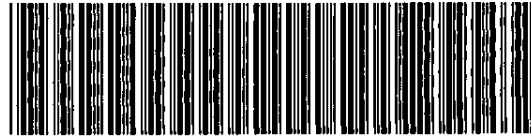

"The name of this corporation is Sheppard, White and Kachergus, P.A."


3. The date of adoption of the foregoing amendment was January 17, 2012.
