ARTICLES OF DISSOLUTION

- FIRST: The name of the corporation, as currently filed with the Florida Department of State, is MELLON SECURITY & SOUND SYSTEMS, INC. (the "Corporation").
- SECOND: The Company was incorporated on January 3, 1978. The document number of the Corporation is 556955.
- THIRD: The dissolution of the Corporation and the filing of these Articles of Dissolution were approved by written consent of all of the shareholders of the Corporation pursuant to Section 607.0704.
