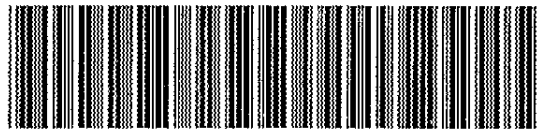

ARTICLES OF INCORPORATION
OF

FIRST: The name of this corporation is:

SECOND: The general purposes for which the corporation is initially organized is the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

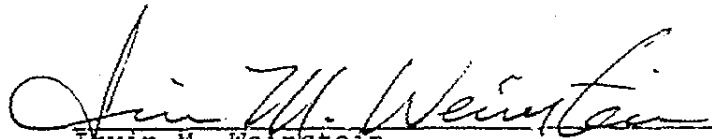
