## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NU-WEST FLORIDA, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation hereby adopts the following amendment to Article III of its articles of incorporation, said amendment being effective on the 31st day of December, 1994:

1. The name of the corporation is NU-WEST FLORIDA, INC.

2. The first paragraph of Article III of the Articles of Incorporation of the corporation was and is amended as follows which amendment was adopted to be effective on December 31, 1994 (material added is underscored and material deleted is lined through):

The maximum number of shares of all classes that this corporation is authorized to issue and have outstanding at any time is 45,000 95,000, consisting of 10,000 60,000 shares of Common Stock, having a nominal or par value of \$1.00 per share and 35,000 shares of one series of Preferred stock, having a par value of \$1.00 per share.

3. The amendment was adopted and approved by all shareholders of all classes and by all directors of the corporation by unanimous written consent dated December 16, 1997. The effective date of the foregoing amendment was December 31, 1994. The number of votes cast for the amendment by the holders of all shares of common stock and by the holder of all Preferred Stock was sufficient for approval.
