The name of this corporation is: DEVINE VENTURES, INC.


3. The date of adoption of the foregoing amendment was July 6, 2015.



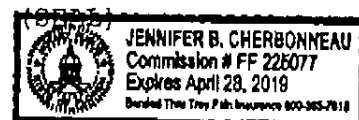
