

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SPRAGGINS, INC.



Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned hereby adopts the following Amended and Restated Articles of Incorporation:

- 1. The name of the corporation is Spraggins, Inc. (the "Corporation"). The date of filing the original Articles of Incorporation with the Secretary of State was April 1, 1978. The document number assigned to the Corporation by the Florida Department of State is No.: 567978.
- 2. The Amended and Restated Articles of Incorporation were unanimously adopted and approved by the Board of Directors in accordance with Sections 607.1003, 607.1006, and 607.1007 of the Florida Business Corporation Act and do not contain any amendment requiring shareholder approval,
- 3. The Articles of Incorporation are hereby amended and restated in their entirety as follows:

ARTICLE I

The name of the corporation is Spraggins, Inc. (hereinafter called the "Corporation").

ARTICLE II

The address of the principal office and mailing address of the Corporation is 3001 Mercy Drive, Orlando, Florida 32808.

ARTICLE III

The purpose for which the Corporation is organized is to transact any lawful business.

ARTICLE IV

The Corporation shall have the authority to issue one hundred thousand (100,000) shares of Common Stock having a par value of \$0.10 per share. Each issued and outstanding share of Common Stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

ARTICLE V

The effective date of these Amended and Restated Articles of Incorporation shall be July 2, 2019.
