ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF FLORIDA MUNICIPAL ADVISORS, INC.

Upon consent of the undersigned as all of the Directors and shareholders of the Corporation at a meeting held on June 12, 1997, the following Resolution was passed as permitted pursuant to Florida Statutes and the Company's By-Laws, being an action of the holders of more than a majority in interest of the voting common stock of the Corporation:
