**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
ROBBINS, BELL & KREHER, ARCHITECTS, INC.**

ROBBINS, BELL & KREHER, ARCHITECTS, INC., a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE I

Corporate Name and Principal Office

The name of this corporation is RBK ARCHITECTS, INC. and its principal office and mailing address is 1771 E. 9th Avenue, Tampa, Florida 33605."

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.

3. The amendment recited in Section 1. above has been duly adopted in accordance with the provisions of §607.0821, .0704, .1003 and .1006, Florida Statutes, shareholders holding the majority of stock of the corporation and all directors having executed a written statement, dated July 19, 2005, manifesting his intention that the amendment be adopted.
