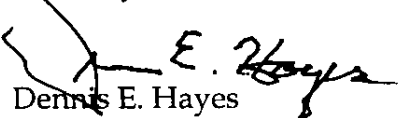

**ARTICLES OF DISSOLUTION OF

I Stephen R. Sedgwick, President, sole director and sole stockholder, respectively, of Sedgwick Associates, Inc., a Florida corporation (the "Corporation"), hereby certify as follows that:

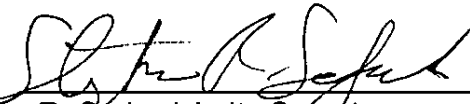
1. The name of the Corporation is Sedgwick Associates, Inc.
2. The Corporation was incorporated under the laws of the State of Florida effective May 31, 1978.
3. By special meeting conducted Friday, June 21, 2013 at 10:00 a.m., the dissolution of the Corporation was authorized and approved by the sole shareholder of the Corporation effective as of June 30, 2013.
4. The decision of the sole shareholder for dissolution is sufficient for approval of the dissolution upon the terms proposed.
5. All debts, obligations, and liabilities of the corporation have been paid or discharged or adequate provisions have been made therefore, except as follows:
