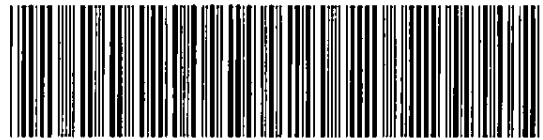

ARTICLE I.

NAME: The name of this corporation is RECLAMATION, INC.

ARTICLE II.

DURATION: This corporation shall have perpetual existence.

ARTICLE III.

PURPOSE: This corporation is organized for the purpose of engaging in all aspects of strip-mine reclamation in Florida, including planning, seeking public and private funding under appropriate Florida law, and physical land reclamation of strip-mined regions, and for purposes of transacting any or all other lawful businesses.

ARTICLE IV.

CAPITAL STOCK: This corporation is authorized to issue 500 (five hundred) shares of one-dollar (\$1.00) par value common stock, which shall be designated "common shares."

ARTICLE V.

PREFERENCES, LIMITATIONS, AND RELATIVE RIGHTS OF SHARES OF CAPITAL STOCK:

SECTION 1. Dividends

The Board of Directors may declare and pay dividends upon the common shares.

SECTION 2. Rights upon liquidation or dissolution

In the event of any voluntary or involuntary liquidation, dissolution, or winding up of this corporation, the remaining assets of this corporation shall be payable to and distributed ratably among the holders of record of the common shares.

SECTION 3. Voting rights

Except as otherwise provided by law, the entire voting power for the election of directors, and for all other purposes, shall be vested exclusively in the holders of the outstanding common shares.

ARTICLE VI.

PREEMPTIVE RIGHTS: Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII.

INITIAL REGISTERED OFFICE AND AGENT: The street address of the initial registered office of this corporation is 222 South Monroe Street, Tallahassee, Florida 32302, and the name of the initial registered agent of this corporation at that address is THOMAS A. HERBERT.

ARTICLE VIII.

INITIAL BOARD OF DIRECTORS: This corporation shall have 4 (four) directors initially. The number of directors may be either increased

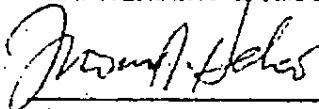

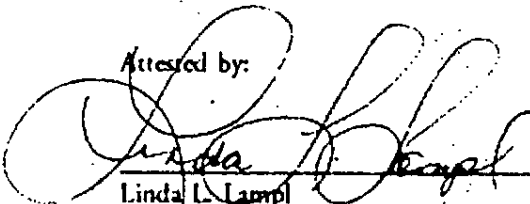

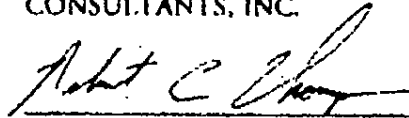
