Enclosed you will find check no. 1840 in the amount of \$150.00 representing the filing fee for the above referenced corporation's Corporate Annual Report.

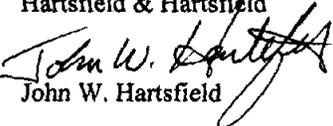
As we have discussed by telephone today, I am writing you to further explain why the filing fee was not paid by May 1, 1998 and to request that the penalty of \$400.00 be abated for the following reasonable cause.

As noted in my letter to the Department dated July 9, 1998, D&D Rentals, Inc. sold substantially all its assets during 1997. The company effectively had no trade or business operations from that time forward. Therefore, the P.O. box (mailing address) of the company has not been used (i.e. checked for mail) as it was during the time of operations. Furthermore, a new P.O. box was acquired for the corporation (P.O. Box 2473) and is now being used. As a result the first notice for the Corporate Annual Report was not received and paid on time.
