Pursuant to the provisions of Sections 607.1003 and 607.1006, Florida Statutes, Intercoastal Distributors, Inc. adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Intercoastal Distributors, Inc. (the "Corporation").
2. The original Articles of Incorporation for the Corporation were filed on July 21, 1978 and assigned Charter No. 579839, and amended by Articles of Amendment to the Articles of Incorporation filed on December 27, 1979.
3. By written consent executed as of this date by the sole director of the Corporation and the holders of all of the issued and outstanding shares of common stock of the Corporation, the sole director and the holders of all of the issued and outstanding common stock of the Corporation have agreed that the Articles of Incorporation of the Corporation be amended, and do hereby amend the same, to change the name of the Corporation to Ex-Tile Company, Inc. Article I of the Articles of Incorporation of the Corporation is hereby amended and restated as follows:

**ARTICLE I.**

The name of this corporation shall be:

**EX-TILE COMPANY, INC.**

4. The number of votes cast for the amendment by the shareholders of the Corporation were sufficient for approval.
