Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

FIRST: The name of the corporation is ELECTRICAL CONSTRUCTION & COMMUNICATIONS INC. The Corporation Document Number is 580113.

SECOND: Amendments adopted:

ARTICLE V – Stated Capital

The total number of shares of stock which the Corporation is authorized to issue is Five Thousand (5,000) of voting common stock with a par value for each share of One Cent (\$0.01) amounting to Fifty Dollars (\$50.00) in the aggregate and Five Thousand (5,000) of non-voting common stock having a par value of One Cent (\$0.01) amounting to Fifty Dollars (\$50.00) in the aggregate.

THIRD: The date of the above amendments adoption is June 9, 2022.

FOURTH: Adoption of the above stated amendments was unanimously approved by the shareholders and directors. The number of votes cast in favor of the amendment by both the shareholders and directors was sufficient for approval of said amendment.
