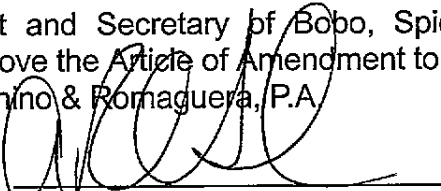
Pursuant to the provisions of §607.1006 Florida Statutes, the undersigned Corporation
adopts the following Article of Amendment to its Articles of Incorporation:
