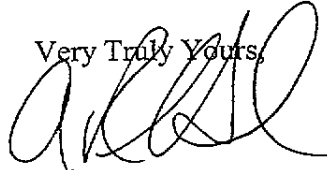

Pursuant to the provisions of §607.1006 Florida Statutes, the undersigned Corporation adopts the following Article of Amendment to its Articles of Incorporation:

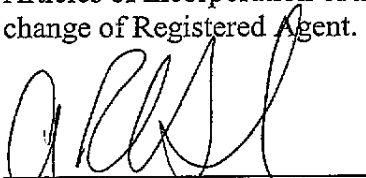
1. The name of the Corporation is Bobo, Spicer, Ciotoli, Fulford, Bocchino & Romaguera, P.A.

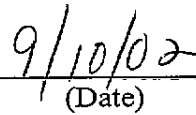
