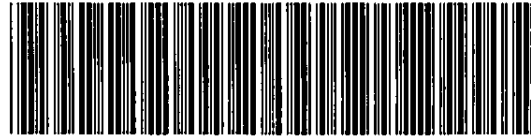

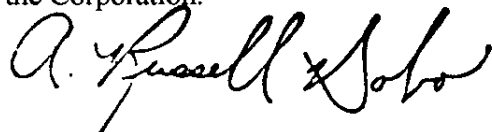

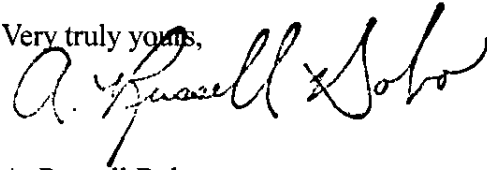

adopts the following Article of Amendment to its Articles of Incorporation:
