The Articles of Incorporation of the undersigned professional corporation were originally filed on October 1, 1978 and assigned document number 585626. The Articles of Incorporation were amended on June 11, 1985, November 7, 1986, January 1, 1990, and October 8, 1997. Pursuant to the Professional Service Corporation And Limited Liability Company Act and the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Batson, Carnahan & Co., P.A. (the "Corporation").

2. "ARTICLE I. NAME" of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read as follows:

"ARTICLE I.

NAME: The name of the corporation is JMBB Services, P.A. "

3. The Articles of Amendment were duly approved and unanimously adopted by the Board of Directors of the Corporation on February 1, 2002. The Board of Directors recommended approval of the Articles of Amendment to the Shareholders.

4. The Articles of Amendment were voted upon and duly approved, adopted, and ratified by all of the Shareholders of the Corporation on February 1, 2002.

5. The number of votes cast for approval of the Articles of Amendment by the Shareholders was sufficient for approval.
